## The “Dare to Create with Wacom & Adobe” promotion

Registration includes a statement of Your personal contact data and a valid e-mail address, as well as entry of the serial number of the product and a statement of the purchase date.  
After correct completion of the registration information within the Registration Period and fulfillment of all conditions above, a unique voucher code will be generated.  
This voucher code will allow you to access the Extras. This Adobe voucher code can only be redeemed on the Adobe® Software download website [www.creative-cloud.com/redeem](http://www.creative-cloud.com/redeem) on which you can download the software by signing in with your Adobe ID or signing up to get a member account and entering the software release code.  
The Extra must be redeemed by the 30th April 2018 („Redemption Period“). A cash payout or combination with other rebates or credit is not possible.
